<u>Candy Corn Guessing Game</u>: candy corn, mason jar, a bucket for the guesses. This was hosted at the front door, which held the line up. This should have its own table to allow kids the time to write on the paper. The prize wasn't offered at the event because we didn't have enough time to review. The winner will come into city hall to pick up. Should offer candy and non-candy item at this table too with a costumed volunteer!

Entry Table: need a festive table cloth, set up programs (much better to design a map of vendors with their activities) – also use the programs to gage how many participants. Make the program a coloring sheet, so we are able to give to EVEY child attending.

<u>Craft Supplies</u> (have everything pre-cut and easy to use) – Pup color pages, crayons

Scissors (right and left-handed – need to buy left-handed), glue sticks, black sharpies, construction paper (pre-cut dog ears, nose, eyes, spots, tongue, etc.), googly eyes



<u>Candy and non-candy item</u>: assorted pack of 400 candy (could have divided that to half the amount), assorted goodies (bought last year – spider rings, yo-yos, necklaces, bracelets, pencils, etc.)

<u>Donut Eating Contest</u>: 6 dozen mini glazed donuts, black yarn (need more than one spool), 3 pair of scissors, 4 plastic table clothes (cover the floor), Clorox wipes, pop-up tent (hung donuts from the tent – worked GREAT)

Costume Contest: Signs for age groups, caution tape to separate the groups, prizes

**Expenses:** supplies

**Profit:** This is a FREE community event – fully sponsored. Some city expense.

#### Lessons Learned:

- Costume contest should be MUCH earlier I thought I would host it at the end to allow all visitors to arrive, but most guests come and go. The costume contest judges should sit at a table facing the contestants to allow quick judging. Also each judge will have their own survey to judge, so it's not a conversation in front of parents and contestants.
- Must bring the PA system to better guide the crowd. Also, have pre-planned Halloween Jokes to share throughout the event some MC talking points.
- Photos by Ben need more than an hour for setup.
- Would like more 6 foot tables, more volunteers, more yarn, buy left-handed scissors, festive table cloths...
- The Chamber's 'safe trick-or-treat' event has over shadowed my business participants only three businesses participated. Even with the minimal vendors, it was GREAT.
- Maybe ask the Bondurant Community Library to borrow their Halloween blow-up decorations??
- Maybe next year, a fun incentive/benefit for the participating vendors, I will design color pages that kids can color at the event of take home each color page will have the vendor's club/business information.

Notes: I say it a lot, but I think this was the best attended Bondu Spook-tacular. We had a lot of visitors!

**Survey Monkey Results:** 100% of the survey takers want to see the event next year! Somethings they suggest we work on is: a more variety of age-specific activities (comments about wanting more toddler activities and more 8-13 activities), prevent lines (may have been crowded), and host costume contest earlier in the event. Their favorite activities were the Haunted House and Donut Eating Contest. Great, friendly, and GOOD staff. Great kid's community event.
