SUMMARY EXPLANATION: The library will be expanded by 7236 square feet in lieu of the 5212 square feet in the original agreement and will have 2000 square feet of the existing building remodeled. In addition to the building construction, some site modifications will be made to the driveways and parking.

These changes have led to the need to update the FEH contract, adjusting the architect's fee to \$270,062.00
