ITEM TITLE: Resolution Approving Purchase Replacement Pickups



SUMMARY EXPLANATION:

As a part of the FY20 Capital Equipment Replacement Budget Staff had budgeted for the replacement of one of the fleet trucks. The budgeted dollar amount for this purchase was \$45,347. In having the ability to leverage the State of Iowa Purchasing Contract that allows the City to receive a significant discount on vehicle purchasing. Stew Hansen’s Dodge was awarded this contract this year. The selected vehicle replacement cost is in the amount of \$31,714.00. The balance of the funds will go towards the purchase of equipment to outfit this vehicle to make it more of a multipurpose truck for everyday use in Public Works and Parks and Recreation.

Along with the Truck mentioned above Staff was also able to include Capital Vehicle Replacement for FY21 into the recent General Obligation Bond Funding. This will allow for the replacement of Public Works oldest truck and allow us to add a truck to the fleet as we continue to grow. The total amount that was in the FY21 budget for replacement was \$66,473. With being able to leverage the State contract as well as trade-in value of 2 trucks being replaced the total amount for both vehicles is \$36,629.70. A small portion of the balance will be used for equipment to outfit both trucks.

Staff would recommend approval of the purchase of the 3 trucks from Stew Hansen’s Dodge City in the amount of \$68,343.70.
