**ITEM TITLE:** Resolution authorizing Metro Waste Authority to renew existing contract for the collection of Municipal Solid Waste on behalf of the City of Bondurant

**SUMMARY EXPLANATION:**

The City's primary contract for waste collection concludes on June 30, 2020, however, there are three, one-year renewal options. The first renewal would go into effect July 1, 2020.

The contract with ASI still offers the lowest rates in the Metro for solid waste. If the service level remains high through next year, making the second one-year extension a good option for the city, then the following year (FY 22-23), there is a unique opportunity to bundle all curbside programs (garbage, recycling and solid waste) for potentially the lowest cost with the highest service long-term. This model has not before been available to the Metro.

Attached is a resolution extending the contract for one year. If the Council approves this resolution, the matter will be on the Metro Waste Authority's May board meeting on May 20<sup>th</sup>.

**A RESOLUTION AUTHORIZING METRO WASTE AUTHORITY (“MWA”) TO RENEW THE EXISTING CONTRACT FOR THE  
COLLECTION OF MUNICIPAL SOLID WASTE ON BEHALF OF THE CITY**

**WHEREAS**, the City is a member of MWA and its comprehensive planning area; and

**WHEREAS**, by agreement dated December 10, 2012, Ankeny Sanitation, Inc. (“Contractor”) and MWA entered into an Agreement for the Collection of Solid Waste (the “Agreement”), as amended, wherein Contractor agreed to collect, transport and dispose at the MWA Landfill or Transfer Station all solid waste material from eligible residences of the Participating Member Communities from July 1, 2013, through June 30, 2020; and

**WHEREAS**, Section 2 of the Agreement provides that the term for which the Contractor shall provide the Collection Services under this Agreement shall commence on July 1, 2013 (the Commencement Date), and expire on June 30, 2020 (the “Expiration Date”). The Agreement may be extended for up to three (3) one (1) year periods at the sole discretion of MWA; and

**WHEREAS**, MWA currently manages the collection of solid waste on behalf of the City and other cities within Polk County; and

**WHEREAS**, the City of Bondurant agrees to have MWA renew the current contract for another one (1) year term—from July 1, 2020 through June 30, 2021—to manage the collection of solid waste within the City, as it is more cost effective for the City if MWA manages said collection contract; and

**NOW THEREFORE BE IT RESOLVED** that the City hereby authorizes MWA to renew the existing contract for the collection of solid waste on behalf of the City and the City agrees to be bound by the provisions of said contract.
