SUMMARY EXPLANATION:

Staff is seeking approval to perform additional year-end transfers to correct fund distribution and to zero out a capital project fund.

First, earlier a transfer was made from the General Fund to the Project Bluejay fund to allocate the funds collected from the building permit fees for construction management services, however those funds had already been receipted into the project fund when the City received the original payment. Therefore, the transfer was erroneous and this resolution corrects that transfer to put the money back into the General Fund.

Additionally, there are funds left in the TIF-Parkland Purchase fund from when the City purchased additional ground to expand the Bondurant Recreational Sports Complex. Currently, the City also has a capital project fund for BRSC improvements, not all of which have been completed. Because both of these projects were funded by TIF, it makes sense to zero out the TIF-Parkland Purchase fund (because that transaction is complete) and transfer those funds to the BRSC improvement fund.

Last year the City reconstructed a portion of Lincoln Street. In February 2019, when the Council awarded the contract, the bids had come in over the estimated amount. At that time, the Council took action to reduce the scope of the project and made the decision to transfer funds from Road Use Tax operational funds (\$50,000) and Water operational funds (\$75,000). Now that the project has been finalized and final numbers are lower than projected, it is necessary to transfer only \$39,729.70 to zero out the project. Staff recommends transfer this amount from Water to the project fund to close the fund.
