**ITEM TITLE:** Amendment of City of Bondurant Code of Ordinances Chapter 63 Speed Regulations

**SUMMARY EXPLANATION:**

This amendment is a follow-up to previous discussion about reducing the Speed limit along Grant Street South to help facilitate the improvements that are being made as a part of the SW District Corridor Project now and as The City prepares to initiate discussion and design on the remaining portion of Grant Street South. Please also see the attached memo from Project Engineer from Shive-Hattery.

This ordinance amendment is back before you again as there was language presented in the most recent ordinance that needs clarification. The text for Section 6 A. calling out Pleasant St SE had inadvertently been struck through and should not have been. The struck language should have been Section 6 B. which is the portion of Grant Street South from 15<sup>th</sup> St SE to the South Corporate limit. Below is the appropriate language.

Staff would recommend approval of the of the text amendment to Ordinance Code 63.04.

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF BONDURANT, IOWA, 2002, BY  
AMENDING CHAPTER 63, SPEED REGULATIONS

**BE IT ENACTED** by the City Council of the City of Bondurant, Polk County, Iowa:

Section 1. **SECTION AMENDED.** Chapter 63, Section 04 D., of the City's Code is hereby amended to add the following languages:

D. For a portion of Grant Street South, from NE Hubbell Avenue/Hwy 65 to Interstate 80 or the South Corporate Limit of the City of Bondurant, the speed limit shall be forty (40) miles per hour;

Section 2. **SECTION AMENDED.** Chapter 63, Section 04, Subsection 6 B, of the City's Code is hereby amended to delete the following language:

6. Special 50 MPH Speed Zones. A speed in excess of Fifty (50) miles per hour is unlawful on any of the following designated streets or parts thereof.

~~B. On Grant Street S, from 15<sup>th</sup> Street SE, to the south corporate limit;~~

Section 3. **REPEALER.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 4. **SEVERABILITY.** If any section, provisions, sentence, clause, phrase or part of this ordinance shall be adjudicated, invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any provision, section, subsection, sentence clause, phrase or part thereof not adjudged invalid or unconstitutional.

Section 5. **EFFECTIVE DATE.** This ordinance shall be in full force and effect following its passage, adoption and publication as required by law.
