





ITEM TITLE: Consideration of Ordinance 200323-208 Amending Chapter 66, Load and Weight Restrictions, Removing Second Street from Designated Truck Routes

SUMMARY EXPLANATION: This amendment removes 2nd Street as a truck route. Trucks would then be unable to use 2nd Street unless they were delivering in town and needed to use 2nd to access their destination or if they were issued a permit to do so. City staff previously met with the County on this action and will coordinate signage with Polk County after the ordinance is adopted.

ORDINANCE AMENDING CHAPTER 66, LOAD AND WEIGHT RESTRICTIONS, REMOVING SECOND STREET
FROM THE DESIGNATED TRUCK ROUTES

BE IT ENACTED by the City Council of the City of Bondurant, Polk County, Iowa:

Section 1. **SECTION AMENDED.** Chapter 66.05 Truck Routes of the Code is amended as follows:

66.05 TRUCK ROUTES. Truck Routes Designated. Every motor vehicle weighing ten (10) tons or more, when loaded or empty, having no fixed terminal within the City or making no scheduled or definite stops within the City for the purpose of loading or unloading shall travel over or upon the following streets within the City and none other:

(Code of Iowa, Sec. 321.473)

- A. U.S. Highway 65;
- B. Grant Street, South between Interstate 80 north to U.S. Highway 65;
- C. ~~Second Street, Northeast and Second Street, Northwest from the west city limit to the east city limit;~~
- D. Grain Street.

Section 2. **REPEALER.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 3. **SEVERABILITY.** If any section, provisions, sentence, clause, phrase or part of this ordinance shall be adjudicated, invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any provision, section, subsection, sentence clause, phrase or part thereof not adjudged invalid or unconstitutional.

Section 4. **EFFECTIVE DATE.** This ordinance shall be enforced immediately.
