**ITEM TITLE:** Second Reading of Ordinance amending Chapter 69, Parking Regulations

**SUMMARY EXPLANATION:** Attached is a draft ordinance amending Chapter 69 of the Cities Traffic Ordinance code to change the No Parking pattern on Deer Ridge Drive NW.

This was discussed during the consideration of the Sankey Summit Plat 2 preliminary plat. City staff as well as Engineers from Veenstra & Kim developed traffic calming solutions for Deer Ridge Drive NW. This is the No Parking pattern and Phase 1 of the overall traffic calming approach. Future phases will include fully controlled intersections at Deer Ridge Dr. NW and Mulberry Dr. NW and Deer Ridge Dr. NW and Aaron Ave. NW. City staff is also looking into implementing Curb Extensions and Pedestrian Islands for additional traffic calming measures along Deer Ridge Dr. NW.

A map depicting the changes is on the next page. Future parking north of Aaron Avenue would be on the east side of the street.

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF BONDURANT, IOWA, 2002, BY  
AMENDING CHAPTER 69, PARKING REGULATIONS

**BE IT ENACTED** by the City Council of the City of Bondurant, Polk County, Iowa:

Section 1. **SECTION AMENDED.** Chapter 69, Section 08, of the City's Code is hereby amended to add the following languages:

35) Deer Ridge Drive NW, from Second St. NW to Aaron Ave. NW, east side of the street, excluding 35a

35a) Deer Ridge Drive NW, from 150 feet North of 6<sup>th</sup> Ct. NW to Walnut Drive NW, west side of the street.

Section 2. **REPEALER.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 3. **SEVERABILITY.** If any section, provisions, sentence, clause, phrase or part of this ordinance shall be adjudicated, invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any provision, section, subsection, sentence clause, phrase or part thereof not adjudged invalid or unconstitutional.

Section 4. **EFFECTIVE DATE.** This ordinance shall be in full force and effect following its passage, adoption and publication as required by law.
