ITEM TITLE: Consideration of one or more readings of an ordinance 200323-209 to amend the

Bondurant Code of Ordinances, Concerning Solid Waste Collection rates.

SUMMARY EXPLANATION: Each year, the collection contract for solid waste in Bondurant provides for an adjustment in the collection price based on three factors: year-to-year changes in CPI, diesel fuel index and the tipping fee at the landfill. Last year the City avoided passing the rate increase to residents by switching to only one city wide clean-up day and also tapping into garbage reserves. The garbage reserves are not strong enough to absorb this increase again.

The City was notified by Metro Waste Authority of a 2¢ recycling monthly increase for each toter. Metro Waste Authority is also raising garbage rates 2¢ each effective July 1, 2020. The rate for the 96 gallon garbage toter increases from \$8.90 to \$8.92. The rate for the 48 gallon garbage toter increases from \$8.20 to \$8.22. The rate for the recycling toter increases from \$3.60 to \$3.62.

Recycling rates were last increased on April 1, 2019. Garbage rates were last increased July 1, 2018.

CITY OF BONDURANT ORDINANCE NO. 200323-209

AN ORDINANCE AMENDING THE CITY CODE OF BONDURANT, IOWA, BY AMENDING CHAPTER 106 – COLLECTION OF SOLID WASTE

BE IT ENACTED by the City Council of the City of Bondurant, Polk County, Iowa:

<u>Section 1.</u> **SECTION AMENDED.** Chapter 106, Section 106.09 of the Code of Ordinances of the City of Bondurant, Iowa, 2002, is hereby repealed and the following adopted in lieu thereof:

106.09 COLLECTION FEES. The collection and disposal of solid waste as provided by this chapter are declared to be beneficial to the property served or eligible to be served and there shall be levied and collected fees therefore in accordance with the following:

- A. For each residential premises and for each dwelling unit of a multiple-family dwelling for either a 96 gallon toter \$8.90 \$8.92 per month, per toter
- B. For each residential premises and for each dwelling of a multi-family dwelling for a 48 gallon toter- \$8.20 \$8.22 per month, per toter
- C. Recycling Fee \$3.60 \$3.62 per month, per toter

<u>Section 2.</u> **REPEALER.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

<u>Section 3.</u> **SEVERABILITY.** If any section, provisions, sentence, clause, phrase or part of this ordinance shall be adjudicated, invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any provision, section, subsection, sentence clause, phrase or part thereof not adjudged invalid or unconstitutional.

<u>Section 4.</u> **EFFECTIVE DATE.** This ordinance shall be in full force and effect following its passage, adoption and publication as required by law.
